Special One Day Entertainment License

1. Retro application made by Amy DeFeudis representing **Dance Designs** for a one day entertainment license: a dancing performance "Dancers Making Waves", to benefit Katelynn's Closet of Hyannis held on December 18, 2021 between the hours of 9am and 5pm at Barnstable High School Performing Arts Center located at 744 West Main Street, Hyannis.

Hoxie confirmed with Director Hartsgrove that the application was in order.

New Junk Dealers License

1. Application made by Donna Nagle d/b/a/ **WhirlWin**, 3219 Main Street, Barnstable to sell second-hand goods.

Donna Nagle is representing the application. She proposes to sell vintage and antique clothing as well as second hand goods; childrens items, books, toys, some wooden art, furniture, other household used items and handmade jewelry. Decker confirmed with Nagle that she obtained her inventory over time. Karlson-Lidman confirmed with Nagle that this is her first shop.

Amend Annual All Alcohol Common Victualler – Change of Premise Description

- Application made by JKD Restaurant Group, Inc. d/b/a/ **Willow Street Tavern**, 477 Yarmouth Road, Hyannis to change the premise description to read: *Lower level: left side unit consisting of kitchen, 2 restrooms, dining room, with 47 seats (35 table seats, 12 bar seats) storage room, entry way, walk-in refrigerator and freezer, rear outside patio with 11 seats. Upper level: right side unit consisting of entry way and office, kitchenette, 2 restrooms, dining room with 48 seats (24 table seats, 17 bar seats). Combined total number of seats: 99*

Jessica represents this application and explained that she proposed to take over the neighboring space in the hopes of creating an entertainment side while still maintaining a family atmosphere on the other side.

LICENSING UPDATES

1. Licensing Authority - Hartsgrove advised that as of January the Licensing Authority meetings will be remote and zoom links will be provided. She also noted there is an upcoming application for The Karibbean Loung for Live entertainment and she added that Lt. Murphy and Officer Kelsey will be meeting with the owner to discuss the plans prior to hearing. Lastly, Ms. Hartsgrove advised that the application for Garrett’s will be coming back before the Authority in January. Decker questioned the process for hearing Garrett’s application. Hartsgrove advised that the application will need to be advertised for and heard again.

2. Licensing Department – Hartsgrove advised there will be a few applications on the January consent agenda.

3. Police Department – Officer Kelsey advised that after the 1st of the year he will (along with Director Hartsgrove) work on addressing some of the Class II auto dealers to ensure compliance.
