Regulatory Agreement Application 2008-04 to modify Regulatory Agreement 2007-02. The applicant seeks to modify the existing Regulatory Agreement to change use from the approved use of 42 residential condominium units with 20,000 square feet of medical office space to a new use of an assisted living facility with 82 units with support offices, recreational rooms, lounges and cafeteria on the first floor. Additionally, applicant seeks to remove lot #42 South Street, Hyannis, MA, Assessor's Map 327, Parcel 241, consisting of 11,472 +/- square feet, from the 2007-02 agreement said lot to revert to a separate buildable lot. In addition to relief granted in Regulatory Agreement 2007-02, relief is requested for use and any potential merger or zoning status with respect to #42 South Street, Hyannis, MA located in the Greenery Development, LLC. Properties are addressed 42A and 42B South Street, Hyannis, MA located in the Hyannis Village Harbor District and 89 Lewis Bay Road, Hyannis, MA located in the Hyannis Village Harbor District and 89 Lewis Bay Road, Hyannis, MA located in the Hyannis Village Medical Services District and shown on Assessor's Map 327 as Parcel 241 and Map 327 as Parcel 223, respectively .
