### Sandy Neck Board Meeting August 12, 2013

A regularly scheduled meeting of the Sandy Neck Board was held on August 12, 2013 at the Selectmen's Conference Room, 367 Main Street, Hyannis, MA. The meeting was called to order at 7:35 pm by Nate King.

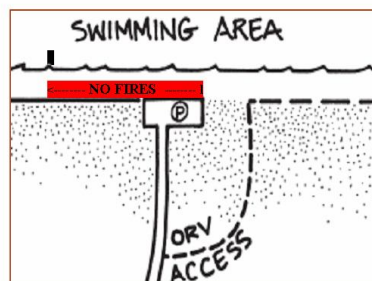

#### Staff Report:

##### *Nina Coleman addressed the Board:*

- The beach opened to Trail 6 on August 6<sup>th</sup>. All chicks have fledged – low number of chicks and nests this season due to overwash and predators. Complete report next month. Everyone happy beach is open. Busy weekend.
- There is a Sandy Neck Flora & Fauna Hike on Wednesday, August 14<sup>th</sup> @ 10 am.
- Fire location plan was discussed and explained. The new fire location was voted on by the Board January 9, 2012. No fires are allowed within the life guard protected area. It is now clearly identified and a picture is on the website. Camp fires are allowed east of the public beach only. The Park Manager has the final word on what is appropriate and what is safe with regard to camp fires. Sandy Neck is one of the few beaches that allow campfires.
- After concerns from patrons and after consulting with recreation regarding the lifeguard station, Nina Coleman will move the lifeguard stand and fire location approximately 100 feet to the west starting next year. This will allow better access to the area down the second set of stairs. This new plan will be for next season. For this season, the most that could happen would be to move the line approximately 20 feet to the west.

**The Board took Public Comment regarding camp fires:**

- Mike Walsh wants the fire area expanded and dogs allowed on the Bodfish Beach.
- Nina Coleman clarified the Bodfish Beach rules and the ORV Beach rules. There has to be a balance and safe environment for all users. Pete Sampou explained that in prior years – with the former expanded fire area – many people going to the swimming area the next day were getting burned from fires left exposed from the night before. It was dangerous.
- Priscilla Jones is concerned that there are so many RVs on the ORV beach. She thinks fewer campers should be allowed so there is more room to walk the beach.
- Dianne Walsh asked about finances for Sandy Neck. She thought there was no overnight fee but there is in fact a charge for overnight parking: \$6 residents, \$6 chase and \$12 for nonresidents. She also did not understand that you can hike to the ORV section and have a campfire and bring your dog with you even if you do not have an ORV.

A **motion** was made by Pete Sampou and seconded by Lynn Heslinga and unanimously voted to support the Sandy Neck Park Manager’s decision to update the 2104 Bodfish Beach Fire Policy by moving the bathing beach boundary and the fire location approximately 100 feet to the west – if possible.

**To clarify:**

- Per Town of Barnstable Regulations – dogs are not allowed on any recreational area from May 15<sup>th</sup> to September 15<sup>th</sup>.
- The Order of Conditions from Conservation does not restrict the number of vehicles but Nina Coleman does limit the number of vehicles due to safety concerns if there is a need to do so.

**Proposed Fee Changes**

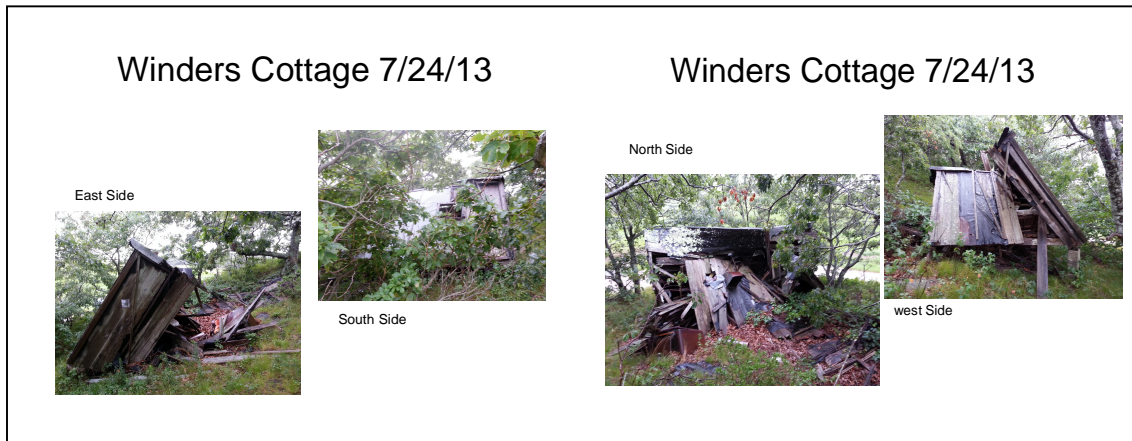

The Board again asked why we continue to give Sandwich Residents a discount for the ORV beach and not treat them as Non-Residents. And also, can the Town Manager Lynch discuss Bodfish Beach fees again with the Sandwich Town Manager. That discussion was put on hold last year. Councilor Daley will ask TM Lynch about it.
