A regularly scheduled meeting of the Sandy Neck Board was held on November 18, 2019 in the Selectmen's Conference Room, 367 Main Street, Hyannis, MA. The meeting was called to order at 7:00 pm by Chairman Tom O'Neill.

- Tom O'Neill addressed the Board welcoming Hank Farnham as the new Board member.

• On a **motion** by Bill Monroe and seconded by Ann Canedy, the Sandy Neck Board voted to approve the October 21, 2019 minutes as printed.

Public Comment:

• Wendy Paquette addressed the Board congratulating Hank Farnham to the Board.

Correspondence:

• Tom O'Neill emailed Town Manager Mark Ells regarding the topics for discussion including coastal resiliency and utilization of the beach.

Staff Report:

Nina Coleman addressed the Board:

- To date there have been 13 cold stunned turtles taken off beach. Kemps Ridleys. Triage Set up in garage and turtles were brought in by Sandwich and Bourne. All in good shape due to the warm weather. Turtle rescue information can be found online on Town Facebook page.
- Gatehouse is open weekends only.
- ORV hours 8a m 4 pm. All vehicles must be off the beach and exit park by 4 pm.
- No campfires allowed.
- Pheasant hunt is ongoing and the deer archery hunt required meeting is November 20, 2019. In order to participate, hunter(s) must attend the meeting.
- Some erosion due to storm and north winds. Some sand in front of lower parking lot has been lost.

Old Business:

Discussion and vote on proposed regulations. On a motion from Bill Monroe and seconded by Pete Sampou. Motion carried with one no vote and one abstention.

New Subcommittees:

1. Conservation and Beach Erosion Along Our Coastlines:

• Vice Chairman Pete Sampou will take the initiative to provide all new Town Council members as well as new Board Member Hank Farnham with the Coastal Resiliency documents for Sandy Neck.

2. Economic Sustainability:

Public Outreach and Public Use & Participation:

Bill Monroe addressed the Board. There is a young man interested in Sandy Neck project for his leadership Eagle Scout service. Bill has been in touch with NRO Sean Kortis regarding potential projects and timeframe.

Bill Monroe addressed the Board regarding an unsafe and derelict cottage on the Marsh Trail. Cottage is identified as the Atwood Cottage #104. Discussion regarding legal ownership, appropriate action for safety reasons, and if the cottage was on the Historic Register. At this time, Town Manager Mark Ells entered the meeting and was asked for assistance in determination of disposition of the property. Town Manager Mark Ells stated ownership rights must be clear and he will put in a request for information and get back to the Board.

New Business:

- Tom O'Neill addressed the Board regarding email he had sent to Town Manager Mark Ells prior to
- Town Manager Mark Ells addressed the Board highlighting the important issues. Many sensitive resources that must be protected with Sandy Neck being one of them. Safety and compliance top two concerns regarding any plans and looking at all options. The Town Manager stated that the Town Council was completely engaged regarding Coastal Resiliency. Questions and discussion followed regarding various potential solutions. The Town Manager then spoke about design and permitting for the Gatehouse project and Access project and timeline. The Town Manager would like to bring the DPW for January Board meeting to discuss the two projects.
- Town Manager Mark Ells spoke regarding beach usage stating that there must be a balance between beach use and conservation regarding the protected species. Nina Coleman addressed the Board regarding the Habitat Conservation Plan that Sandy Neck is a participant of. Nina and NRO Sean Kortis recently attended a stakeholder meeting and said that Sandy Neck is coming up on its' renewal period is coming up and she intends to ask for 4 acres to discourage birds while now there is a two acre restriction. With the HCP the Plovers have been very successful on Sandy Neck. Questions and discussions followed regarding guidance from the town as well as communication.
- Nina Coleman addressed the Board regarding the 2019 Conservation Commission repot as part of the Orders of Conditions to operate an off road vehicle beach. See attached. Discussion and questions followed.

Public Comment:

• Diane Lomba asked about the RFID program and how it worked out this year. Nina Coleman responded that there had been some issues and that staff was working on solutions and the project will be more accurate this upcoming season.
