SHELLFISH COMMITTEE MINUTES OF THE MEETING DATE: June 12, 2024 TIME: 6:30-8:30 PM

Stuart Rapp called the meeting to order at 6:30 PM, as June 12, 2024 meeting of the Shellfish Committee. Stuart read a notice at the beginning of the meeting:

TOPICS FOR DISCUSSION

1. Approve Meeting Minutes: March 13, 2024 and May 8, 2024 minutes

Patricia moved to approve the March 13, 2024 and May 8, 2024 meeting minutes and Gloriann seconded. There was a unanimous vote in favor of approving minutes as written.

3. Natural Resources Report / Correspondence:

1. Shellfish Growing Area Updates

Constable Croteau stated the proposed aquaculture regulation changes were adopted and will be integrated into the town code and e-code. The following relay areas are being stocked; Bluff Point, Handy Point, Cordwood, West Bay, and hopefully Rendezvous for the 4th of July. There are still a

couple openings for the learn to shellfish classes that require people to sign up ahead of time. There is a razor clam closure for at least a year located East of the Barnstable Yacht Club pier to Salton Point.

2. Monthly Propagation Report

Constable Croteau stated that the second seasonal employee, Ceecee, has started with the propagation team. Aidyn, the intern from the MIT Sea grant will be with the Shellfish team for the duration of the season. 42.5 bushels of quahogs were planted in the 3 Bays area, 28 nets were pulled to prepare for more stocking, and all remote set bags from last year have been fully planted in Barnstable Harbor. The kids' clammer class was a huge success amongst the kids who went. For the first time, a quahog painted with pink nail polish was hidden and the kid who found it was awarded a rake.

Paul Hendricks also suggested to Chairman Rapp that he send a letter to DPW regarding the Blish Point boat ramp where the sand is overtaking the ramp. Patricia made a motion to authorize Chairman Rapp to send the letters to the Town Manager, seconded by Robert and unanimous vote in favor.
