ORDERED: That the Town Manager submit a petition to the General Court of the Commonwealth for a special act approving the the grant of an easement to Vineyard Wind LLC, as follows.

"AN ACT AUTHORIZING THE TOWN OF BARNSTABLE TO GRANT AN EASEMENT TO VINEYARD WIND LLC"

Be it enacted by the Senate and House of Representatives in General Court assembled, and by the authority of the same as follows:

SECTION 1: The Town Council shall be authorized to grant an easement to Vineyard Wind LLC, and its successors and assigns, in a parcel of land, namely a portion of Covell's Beach and shown on Assessors' Map 225 as Parcel 006, for the purpose of constructing, installing, inspecting, operating, maintaining, repairing and replacing, subsurface high voltage electric power transmission lines, along with associated subsurface appurtenances including but not limited to subsurface telecommunications lines, conduits, duct banks, bays and vaults, and together with surface appurtenances for access, in connection with the wind generating facility to be developed by Vineyard Wind LLC in federal waters south of Martha's Vineyard.

SECTION 2: The Town Manager may execute and record any instruments necessary on behalf of the Town to effectuate the section 1 upon the passage of this act.

SECTION 3: This act shall take effect upon its passage."

BACKGROUND: The Barnstable Police Department applied for and was awarded a Bulletproof Vest Partnership Grant from the United States Department of Justice, Office of Justice Programs for FFY18 in the amount of \$19,600

This grant funds up to 100% of the cost of bulletproof vests purchased or replaced by the police department in the form of a 50/50 partnership between the Federal Office of Justice Programs and the Massachusetts Executive Office of Public Safety. Replacement of vests is recommended every 5 years, as the reliability of the vest deteriorates over time and use. State reimbursement is only made upon receipt of 50% payment from the Federal program

ANALYSIS: The acceptance of this grant will allow the Department to replace bulletproof vests and maintain safety standards for replacement of these vests on behalf of each police officer at no cost to the Town once the 50/50 reimbursements are filed for and received by the Federal and State grants. These grants offer significant savings to the Town, as each vest costs upwards of \$1,000 and is an expenditure that is anticipated every five years for each officer. Each officer is on a 5 year replacement cycle tied back to the date of the purchase of their first vest. For this reason, these grants are applied for each year that they are made available for application

FISCAL IMPACT: This is a reimbursement grant. The town must expend the funds upfront and subsequently submit for reimbursement. This has no impact on the Police Department's operating budget.

TOWN MANAGER RECOMMENDATION: Mark S. Ells, Town Manager recommends acceptance of this grant.

Fiscal Year 2019 Operating Budget for the purpose of funding the hiring of five current

patrol officer vacancies

BACKGROUND: The department has 5 patrol officer vacancies and would like to begin the hiring process and enroll the 5 new recruits in the next available Police training academy in April 2019 conducted by the Massachusetts Criminal Justice Training Council. At the time of the preparation and finalization of the Fiscal Year 2019 budget, the Police Department did not have confirmation on the number of retirements to take place nor the availability of police academy seats that would be available. The costs to hire and secure these 5 academy seats relative to recruiting costs, training and outfitting of these recruits requires a supplemental appropriation to the Police Department's Fiscal Year 2019 Operating Budget in the amount of \$75,400 as outlined below for costs not allocated in the original approved budget:

ANALYSIS: This supplemental appropriation request totals \$75,400 and is comprised of three parts: 1) Pre-employment requirements including medical exams and psychological assessments; 2) academy tuition and textbooks; and 3) uniforms and gear.

FISCAL IMPACT: Funds will be provided from the General Fund Reserves (Free Cash). The balance in the reserves is \$12.6 million. The appropriation will not be added to the department's FY20 base operating budget.

TOWN MANAGER RECOMMENDATION: Mark S. Ells, Town Manager recommends approval of this supplemental appropriation request.

BACKGROUND: The Police Department applied for and was awarded a Federal Fiscal Year 2018 Byrne Memorial Justice Assistance Grant: Local Solicitation from the United States Department of Justice in the amount of \$55,311. The grant has been deemed to be a disparate certification allocation to be distributed among three towns as outlined below based on a prescribed grant formula amount for each town and the Town of Barnstable Police Department will act as the grant administrator and fiscal agent for all towns:

Total Allocation for Town of Barnstable/Barnstable Police Dept.:\$25,940

\$17,000: To purchase an Electronic Sign Board to be used for situational traffic concerns; public safety messaging; and as a public communications tool.

<u>\$8,940</u>: To fund the costs associated with the replacement of obsolete equipment in the Department's Mobile Command Unit/Emergency Operations Center.

Total Allocation for Town of Falmouth/Falmouth Police Dept.:\$11,312

\$10,012: To purchase and replace two (2) Speed Monitoring Awareness Radar Trailers used to assist with speed monitoring and motorist awareness.

<u>\$1,300</u>: To purchase "Body Beacon" rechargeable LED lights for 52 patrol officers to support officer safety when making traffic stops and other patrol-related stops where the visibility of the officer is important to prevent the officer from being hit by an oncoming motorist.

Total Allocation for Town of Yarmouth/Yarmouth Police Dept.:\$18,059

<u>\$10,912:</u> To fund the costs associated with the startup of a Traffic Unit to include data collection and traffic-related patrols. Aside from general traffic enforcement, the unit will also focus on impaired driving, traffic hotspots that generate citizen concern and human trafficking detected through routine traffic stops.

<u>\$7,147</u>: To purchase two (2) lidar speed detection units and a traffic data collection unit to support the initiatives of the newly formed Traffic Unit.

ANALYSIS: The acceptance of this grant will allow the aforementioned police departments to take action on the programs as described previously.

FISCAL IMPACT: There is no matching funding required for this grant. This is a reimbursement grant as expenses are incurred up to the total dollar amount of the grant. The Town of Barnstable Police Department will serve as the fiscal agent for all the towns and will be responsible for all grant reporting, reimbursement of funds and draw downs.
