



TOWN COUNCIL MEETING

January 5, 2012

A quorum being duly present, Council President Frederick Chirigotis called the January 5, 2012, Town Council meeting to order at 7:00 p.m. in the Hearing Room of Town Hall, 367 Main St., Hyannis, MA.

The Pledge of Allegiance was led by President Chirigotis, followed by a Moment of Silence.

PUBLIC COMMENT

Robert Tucker said he was a little offended thought we were not supposed to call the Councilor's by name. Crime is getting very bad, and the homeless is getting very bad in Hyannis. No jobs out there. What is going to happen to the people when they take the unemployment out of Hyannis? What is going on with Mr. Klimm? Where is the money coming from? People want Klimm back.

John Alden said you all represent me as well as your villages. One lesson to be learned from last year, there has to be communication. Is there a committee formed to find a new manager? What is the status of it? No one knows what the heck is going on.

Dorothy Hughes was concerned about Stewarts Creek, the dredging of the creek and the roads that are a mess. When is the dredging going up for bids this fall or next fall? The West Main Street Pumping station, what about that? We have poured money into the Airport and it is still losing money. The Enterprise account seems like it is a way to get money from the town

John Julius read a list of "reprehensible" losses for the Town including the skating rink, the Hyannis Water Company, the Sewer Enterprise account and the Airport. Julius said he will personally email each of the Councilors these numbers. You should be working more.

Beth Marcus read a letter she had sent to each of the Councilors regarding the Nstar Resolution on the agenda. Marcus encouraged the Councilors to vote to not use herbicides to protect our clean water. Please vote in support of the resolution.

Patrick Page apologized for what he called the Council the last time. He has asked for help for six years, now you have done a taking of my land. It is extremely personal; you should be working with me. I'm not the bad guy. Happy New Year.

Sue Phelan asked the Council to support the resolution to abandon the use of herbicides to clear vegetation on Cape Cod transmission rights of way. She said we are just asking them to continue what they have done in the past to ensure the purity of our water. Please pass this resolution tonight, keeping in mind the health of our residents.

Patrick Page said my wife is not here so I would like to speak to the Council for her.

COUNCIL RESPONSE TO PUBLIC COMMENT

- Councilor Canedy asked if Mrs. Phelan will be available to answer questions, and the staff may need to give a response to the questions on enterprise funds.
- Councilor Cullum said the Stewarts Creek project was going out to bid in the winter and work should begin in the fall.
- President Chirigotis stated on January 19th one of the topics will be about Enterprise funds and how they work. Chirigotis said we will be forming a committee to move forward on finding a Town Manager. Chirigotis stated that Mr. Klimm would have to make inquiry to be considered by the committee.

November 17th minutes, changes have been incorporated. Motion to accept as written seconded.

COMMUNICATIONS FROM ELECTED OFFICIALS, BOARDS, COMMISSIONS, STAFF, CORRESPONDENCE, ANNOUNCEMENTS AND COMMITTEE REPORTS

Councilor Daley suggested the Council send a letter of appreciation to the Falmouth Board of Selectman for the oysters.

Councilor Tinsley

- Thank you for the good communication regarding a water break on Bassett Street. The residents were very happy the communication was there and how long it would take, nice job.
- Barnstable Community Horace Mann Charter Public School, school choice applications are available on line.

Vice President Barton

- The Acting Town Manager Contract Negotiating Committee had a meeting and voted to approve the Executive Session Minutes, and voted to release them. There is one more amendment and Barton anticipates the minutes will be available on January 19, 2012.

Councilor Dagwan

- Attended the Renewable Energy Committee meeting the subject was about recycling, it was a very enlightening discussion. Some of the smaller haulers came in and told the committee what they were picking up. Summer residents tend to do more recycling than the year round residents.
- On the night of the Homeless Memorial Ceremony Councilor Dagwan and Councilor Barton camped out in a tent in the rain, at the Calgary Baptist Church. It was quite an experience.

2012-034 ORDINANCE AMENDMENT CHAPTER 76, CODE OF BARNSTABLE, SETTING THE SCHEDULE OF FEES TO BE IN EFFECT IN THE TOWN OF BARNSTABLE INTRO: 11/03/11, 11/17/11, 12/01/11, 01/05/12

Vice President Barton made a motion to amend by striking out the following two violations listed under "type of violation":

- Vehicle with expired inspection sticker.....\$50.00
- Vehicle with expired registration plate or decal.....\$50.00

So that Section 1-7 will read as follows:

Rationale given by Tom Lynch, he introduced Tom Geiler, Director of Regulatory Services Department, who explained the differences in the prices. It will help Law enforcement to track the entertainment that moves from establishment to establishment. This will allow us to track this situation and will be easier to manage.

Public Hearing opened and closed.

Councilor Canedy asked is this for the establishment or for the individual?

Councilor Tinsley liked "cheaper quicker and easier." This item number is different, on page 3, there is no section listed for Karaoke.

Director Geiler responded there is no state requirement on Karaoke. The others have a state requirement which is what the number and chapter are referring to. Karaoke will only go with Chapter 140 Subsection 183A Entertainment licensing.

Councilor Cullum asked is karaoke live or non live?

Director Geiler responded the concept is the person, like a disc jockey, they have the controls of the sound level and the level of interaction by the crowd.

Councilor Cullum stated an extra fee to a small business owner, coming out of the daily receipts, is a lot of money.

Director Geiler said we understand the needs of our business community. This is an elective type of service not everyone has to buy. Our only alternative is to push those fees onto the real estate taxes.

Councilor Joakim quoted a lesson learned “if a fee that actually gains us more than the cost of the service provided then it actually becomes a tax.

Councilor Cullum small business owners live the day to day, counting the change in the drawer every day, we work very hard.

Town Attorney Ruth Weil said there is no state law, as it is printed in the reference on page 3. Leave the ordinance exactly as written. Leave it exactly as written.

2012-050 AMENDING GENERAL ORDINANCE CH. 220, TOWN COUNCIL, ART. I, MEETINGS 12/15/2011, 01/05/12

Councilor Joakim read the rationale.
Opened to Public Hearing at this time.

Henry Farnham spoke to the proposed amendment as it will curtail the number of public comment periods. Workshops can be incorporated into the regular Town Council Meetings. Council leadership needs to keep the public comment respectful, factual and constructive. If there are repeated offenders ban them from further comment. The residents should not lose the opportunity to be heard. Don't vote for this item.

Patrick Page said he wanted to back up what Mr. Farnham just said. I am being targeted as one of those individuals. This isn't fair to anyone.

John Julius said this is so wrong. Why are we having this discussion? Now you want to work less. You don't have the right to do this. This is reprehensible, to prevent people from coming to this podium to speak their mind. I have a constitutional right to speak at this podium.

Robert Tucker asked please don't take this right away that is not fair to me to take that right away. If you do this I don't want to be a part of Barnstable anymore.

Closed the public meeting

President Chirigotis explained that this is exactly the language in our Charter, there is no difference.

Councilor Joakim said it is the language in our Charter. The language in our code is different; we are not taking away public comment. One regular meeting each month then the second meeting would be workshops to get right to the business at hand.

Recess

Vice President Barton stated we are not removing public comment, just focusing it. Barton read a statement she sent out. The Council needs to talk among themselves. People need to be able to listen to that and hear more dialog and discussion.

Councilor Canedy agreed with what Vice President Barton said, not as a substitute but as an addition. Many times we have had packed agendas. We work for the people, we are obligated to do this, and I will not support this.

Councilor Tinsley said we are not taking public comment away but I would like to offer an amendment. It was not seconded.

Councilor Cullum stated this is a fast learning curve. We are all really excited about new thoughts. I didn't run for office to decide something is inconvenient. I can't vote for it even though my name was at the bottom of this item.

Councilor Cote said one thing we might want to do is table this issue to a date certain, of the 1st meeting in February and revisit it. A motion was made and seconded.

A lengthy discussion ensued, at which point Tinsley withdrew his second.

A motion was made to move the item as written which passed unanimous

Upon motion duly made and seconded it was

ORDERED, that the General Ordinance, Chapter 220, Town Council, Article I, Meetings, is hereby amended by striking out the existing §§220-1 through 220-3 and substituting in their place the following:

2012-052 UPDATING THE NSTAR RESOLUTION OF NO-SPRAY, PESTICIDE-FREE VEGETATION MANAGEMENT ON CAPE COD & THE ISLANDS, INTRO: 01/05/12

Rationale read by Councilor Joakim.

Councilor Daley asked the Council to support this resolution.

Councilor Canedy said she is in support of this resolution, but has two points

- This is non binding for Nstar.
- Postpone until we can be more educated or commit to a workshop after having voted on it.

Councilor Dagwan is in support of this resolution.

Councilor Joakim stated that although it is non binding, she is in support of this resolution.

Councilor Cullum said since it is non binding, vote for sure; but I am interested in learning more about the pesticides.

Councilor Tinsley asked how far can it go in the air, ground water contamination, and tree damage. Nstar could plant weed suppressing cover crops that stay low. I will definitely vote for it.

Vice President Barton echoing the others, said we have a sole source aquifer, we have to protect ourselves.

Councilor Rugo made a motion to move the item, it was seconded

Vote: 10 Yes, 1 No (Canedy)

RESOLVED, that the Town Council supports the continuation of its 2010 resolution requesting NSTAR to commit to a no-spray, pesticide-free vegetation management policy on Cape Cod and the Islands.

The Town of Barnstable requests that NSTAR to abandon its current plan to use herbicides along rights-of-way on Cape Cod and commit to a NO-SPRAY, PESTICIDE-FREE policy of vegetation management on Cape Cod and the Islands.
