



## TOWN COUNCIL MEETING March 20, 2014



**A** quorum being duly present, Council President Jessica Rapp Grassetti called the March 20, 2014, Town Council meeting to order at 7:00 p.m. in the Hearing Room of Town Hall, 367 Main St., Hyannis, MA.

An announcement was made by President Rapp Grassetti regarding the meeting being televised live and questioning if anyone was actively taping the session to please make their presence known. This session is recorded and broadcast on Channel 18.

The Pledge of Allegiance was led by President Rapp Grassetti, followed by a Moment of Silence.

### **PUBLIC COMMENT:**

President Rapp Grassetti announced that due to a potential error in the legal posting of Item 2014-067 this item will be postponed to next meeting.

### **PUBLIC COMMENT:**

Ron Beaty announced a debate on Friday March 28 at 7 pm

Hilliard Welch spoke out regarding the Cape Cod Commission. Welch gave an overview of some of the purposes of the Cape Cod Commission, such as balanced economic growth.

Lou Gonzaga wants the people of Barnstable to make the decision by voting regarding the withdrawal of Barnstable from the Cape Cod Commission. The Commission has hindered Cape Cod.

Chris Bartley told the Council that the Cape Cod Commission is unconstitutional, very unneeded, and over regulation.

Margaret Van Sciver spoke about the Cape Cod Commission and asked the Council to reflect on the successes and offer their full support. There are common challenges throughout the Cape that must be met, utilize the Cape Cod Commission.

Helen Bresnahan reported from her experience with the Cape Cod Commission, they were consistent, keep the Cape Cod Commission, to continue to keep conservation land in good condition.

Steve Brown uses the Cape Cod Commission's knowledgeable staff for land use water quality. This staff has the time and resources, are very receptive which allows Brown to work more efficiently. We have a regional effective qualified commission to provide these services

Christopher Mc Gowan stated Wastewater management is foolhearty and megaton foolish. Don't let the obsession of the few be a catastrophe for the many.

Sue Rohrbach said she was disappointed Town Council will not vote tonight. The professional staff at the Cape Cod Commission works hard for the benefit for all of us on the Cape. They have the resources and the funding to handle wastewater in the most efficient way. Say no to this item.

Meg Loughran said she was disappointed about the process this evening; and wondered if there is a back story to this.

Nancy Ayotte stated smart regulation is good for business, protects waterfront, and protects the water. The Commission can access federal and state funds. We have to move forward. Please be wise stewards to the town.

Felicia Penn shameful Barnstable politics at its very best...ask the town attorney to speak to the postponement. We are the biggest town and we should lead.

Patrick Parquette from Beach Access Coalition expressed his support, he asked the Council to support this item. Parquette feels that if the residents and visitors can't go to the beach, they will go somewhere else. He urged the Councilors to see how our beaches are managed and become part of the Section 10 grant program.

Rick Presbrey of the Housing Assistance Corporation is celebrating their 40<sup>th</sup> year and is very impressed with the Cape Cod Commission and what they do for the towns. He said the people of the town need to know how this works, what the commission has done.

## **COUNCIL RESPONSE TO PUBLIC COMMENT**

- President Rapp Grassetti clarified that the vote to postpone was not unanimous, it was 12-1. Since there was an erroneous error in the legal posting it is important to err in the side on caution.
- Vice President Canedy stated that Barnstable is part of the Beach Coalition. Letters have been submitted for inclusion in the state filed habitat state grant. There will be a presentation. Regarding 2014-067, she is disappointed as much as the citizens because we cannot vote tonight. She supports the President and the decision to postpone because the legal posting has an arguable error, binding versus non binding, material issue. It's important to be open and transparent.
- Councilor Cullum thanked everyone for coming out to vote, taking this very seriously.

- Councilor Tinsley thanked everyone for their comments, comments are valid, and we will remember what you said this evening when we vote on this item.
- President Rapp Grasseti reminded everyone they can make comments on agenda items via a link in the website.

**(Report of the Shellfish Committee taken out of order.)**

**Report from the Shellfish Committee:**

- Mr. Stuart Rapp reported they now have a full complement of people on the board. He explained the Aquaculture regulations.

**Councilor discussion and comments:**

- Advise the Town Council what the shellfish issues, often through the Town Manager. The shellfish licenses are issued by the town to farmer with grants -this is a successful program. Virus that has come up from the south waters and is a health issue, "vibrio" found in oysters when the water temperature is warm. Regulations require the shellfish to be iced down by the oyster farmer. Speak to some programs? Large success is North and South side oyster programs, spat shells are distributed in these areas. Town is benefiting from a bumper crop of oysters. Harvest from areas that are closed. Then, moving the shellfish to another area with the help of "BARS" and the Natural Resources Department. There are complaints about aboriginal rights to shell fishing with the belief that they have the right to take without regulations. Are there natural occurring oysters in the town on Barnstable, yes, they are out there.

**Independence House - Executive Director Lysetta Hurge-Putnam and Board of Directors President Lauren Kanzer:**

- They offer free and confidential services to their clients and are now in the 30th year. The Town of Barnstable is the only town that does not help fund or support Independence House. Sandy Cashen, survivor of Independence house, asked for support. Lysetta Hurge-Putnam stated that one in four women will be victim of domestic violence. 15.5 million Children live in homes with domestic violence. Independence House staff helps the clients to become better parents to their children, and have a better quality of life.

**Councilor Discussion and Questions:**

- How many clients do you have? Over 9,000 last year. Every other town contributes; the Town of Barnstable does not have human service funding, do you receive money from the county? We see the drug and alcohol abuse is on the rise does that impact the percentage of domestic violence? Abusive behavior is very deliberate. Alcohol and drugs could be a factor but not a cause. Barnstable did give a small donation of a thousand dollars in the past, asking the Council to try to help find some money. Do our part to support your efforts. Divert funds to look at that side of the equation. Hospitals do you cross reference-yes certainly. Several Barnstable High School students who are members of the Mentors in Violence Prevention Club gave a presentation about there organization. There purpose is to expose pervasive violations of human rights to eliminate the presence of abuse.

### **Cape Cod Symphony Orchestra (CCSO) – presentation:**

- John O'Brien introduced Warren Marsh, President of the non-profit, Kimberly Williams Treasurer, gave a brief overview of the history of the organization. Executive Director Jerry Carter gave some statistics about the CCSO.

### **Councilor Discussion and Questions:**

- CCSO is a great organization it's important to engage children who may not have a chance to participate and see a program the CCSO offers. Major programs which allows children to participate. 60 Children see each classical performance for free. Music is essential; so happy to see this in Hyannis; incredibly rewarding for the students; feasibility study looking at specific sites? Investigated a few sites in Hyannis; parameters funding from the neighborhood; ticket sales contribute to 70% of operating budget. Limitations 40 days to the program if we had the space; different venues like Broadway shows; revenue producing. Was the feasibility study publicly released or an internal document? An internal document. How do you envision how you are going to pay for the center? Donors. Professional fundraisers. Traffic impacts, street changes that will impact the bottom line for the Town of Barnstable. End result is that there is a balancing economic positive for the town; economic development, step in the right direction.

### **Presentation: Regional Beach Access Coalition Members – Selectmen: Wayne Bergeron, Dennis; John Hodgson, (absent) Orleans; Sean Summers, Chatham:**

- Brief update with beach restrictions due to protecting the species, but need to recognize the needs of the residents and the visitors. Visitors come to Cape Cod to access the beaches. Scott Morris from the Beach Buggy Association has been working with Orleans for Regional Beach Access.

### **Councilor Comments and Questions:**

- The Cape is a unique land mass; beaches are all different; work with the towns; appreciate the presentation; we are going to be actively involved. .

**2014-069    AMENDING THE ADMINISTRATIVE CODE, CHAPTER 241, ARTICLE III, MULTIPLE-MEMBER APPOINTIVE ORGANIZATIONS, §241-39, YOUTH COMMISSION INTRO: 03/20/14**

Upon a motion duly made and seconded it was referred to the April 3, 2014 meeting

**ORDERED:** That §241-39 of Chapter 241, Administrative Code, Article III, Multiple-Member Appointive Organization be amended by striking out in its entirety and substituting in its place the following:

**§241-39. Youth Commission.**

*[Added 7-16-1992 by Order No. 92-141; amended 6-12-1997 by Order No. 97-150; 11-4-2004 by Order No. 2005-030]*

**A. Composition; term of office.** There shall be a Youth Commission consisting of eleven members, nine of whom will be between the ages of 13 and 19. These nine members shall serve for a one-year term and may be reappointed as long as they continue to qualify, and they will be the only voting members. Two members shall be adults and will serve for three-year terms, overlapping, as determined by the Appointments Committee. The two adult members will be nonvoting members and serve in an advisory capacity. All members appointed shall provide for a balanced and diverse representation of the community's interests and concerns. One member of the Youth Commission shall serve as a liaison to the Town Council, reporting either in person or in writing, as they are able.

**B. Authority and responsibilities.** The Youth Commission advises and assists the Town Council and Town Manager in the development of policies, programs, and delivery of services for the health and welfare of youth and their families. The Commission shall

regularly assess the needs of youth as individuals and community members and work with all public and private schools located within the Town as well as the Community Services Department, Police and other town departments, multiple member boards and community groups in coordinating or developing mutual efforts to address these needs. The Commission further advises and otherwise assists the Town Manager in utilization of all federal, state, and municipal programs and services available to youth and provides education and referral resources to all members of the community. The Youth Commission is an advisory commission to the town.

### **C. Interrelationships.**

**(1) Town Council.** The Youth Commission interacts with its Town Council liaison and the Town Council to advise the Council relative to the establishment of policies and legislation concerning issues affecting youth within the town. The Board interacts primarily with the Recreation Commission and Golf Commission.

**(2) Town Manager.** The Youth Commission interacts with the Town Manager to ensure that the development and delivery of youth and family services are effective. The Commission receives administrative and staff support from the Department of Community Services.

**(3) Other boards.** The Youth Commission interacts with the Recreation Commission, Golf Commission, Conservation Commission, Sandy Neck Board, Public Works Commission, Historical Commission, J.F.K. Memorial Trust Fund Committee, and other boards as necessary.

Councilor discussion and questions:

Money doesn't go into hard bulkhead improvements? Stayed away from any changes that involved Chapter 91 permitting. What is the condition of wall and dock? We will look into the condition wall and dock. The dock it is at capacity due to the state it is in. This is about the matching grant that was approved in 2012; structural issues are not being tackled. It is suspect if that much money is being spent and there are no substantial improvements. Joanne Miller Buntich stated that hearing these concerns regarding the conditions of wall and dock, she and her staff will investigate Town Council's concerns.
