**Councilor guestions and comments:** Can we discuss the reserve account, what would be the goal? Will you be trying to put the reserves back into your operating budget? [School has joined the Plymouth County OPEB trust, so we will be doing a little better on that, concerned about having too little money is this account] Will you ever be able to spend this money [no forecast on that] 4 % wiggle room how is that money used [we do have a technology line item, we are looking at all 17 programs] Do you use e books, or texts [many textbooks, slowly transitioning] survey for gainful employment, do you have a wage prospective [very difficult to collect the data, use the wage and labor statistics; what entry level employees would make] do you have chrome books [we have used chrome books] do you use robotics [yes, through engineering and technology] school resource officer [partnership with the town of Harwich] High rate of challenged students, what can be done to boost the graduation rate [attract and retain students] Achiever's program, might be a good match; do you do adult ed [some adult offerings at night] programs for alarms, video surveillance [eleventh graders can be trained in low voltage, we do internships] Site visit of the school [sure] As students graduate they have to be familiar with the new technology and equipment used today. Private donations. [we receive periodically. Thumbnail sketch, are you changing the size of the building; [not much bigger than we currently have, just a different configuration] are you keeping your building [no a new facility, based on square footage per student] is your site large enough to do a complete rebuild [unknown as yet]

MSBA building process is very different it has to be done with a district wide vote, majority vote of the entire district-all twelve towns.

 Dan Santos, DPW Director gave an update of the dredging of Barnstable Harbor; water quality issue, is one of the most reviewed, and sampling of sand is necessary; bacteria is to be expected and is normal; County Health Department said the bacteria was fairly low and would not survive. The Hyannis Water system is safe, we meet all the state requirements

Could we mail the e-coli information to Mr. Page [yes] Thank you for addressing this, e-coli and bacteria are rendered harmless; what if someone handled the sand prior to it dissipating [the health agencies, did not find any health issue, they put the sand on the dune face, in an area that is off limits for access by anyone.]

 Mark Milne, Director of Finance, spoke about information to come forward from the Legislator; which changed to a new formula named "economically disadvantaged category," this will increase our aid for our students. He does not expect the Bond rating to change.

Preservation methods include: scanning to compact disc, de-acidification, mending and reinforcing of paper, re-sewing, rebinding or archival grade polyester encapsulation as needed; and that the Town Manager is authorized to expend the amounts appropriated for the stated purposes.
