

Town Council Meeting June 21, 2018



quorum being duly present, Council President Eric Steinhilber called the June 21, 2018, Town Council meeting to order at 7:00 p.m. in the Hearing Room of Town Hall, 367 Main St., Hyannis, MA.

An announcement was made by President Steinhilber regarding the meeting being televised live and questioning if anyone was actively taping the session to please make their presence known. This session is recorded and broadcast on Channel 18.

The Pledge of Allegiance was led by President Steinhilber followed by a moment of silence.

PUBLIC COMMENT:

Tina Carey and Michel Mangalo spoke about their issues with the Business Improvement District, (BID); have been asking for relief from the BID. They have filed a lawsuit today against the Town and the Bid. (Exhibit A)

Joanne Uchman working for over 3 months to stop the antenna tower; has sought legal counsel to stop the permit for the radio tower at the Centerville Church; we have been waiting for a response from the town; should not take this long to solve this issue.

Kathy Duran regarding the memorandum of understanding (MOU) for the leaching of effluent on the athletic fields at the Barnstable High School; previously brought the information of the flooding on Dunn's Pond Road, and the fragile eco system of the pond. The fire department did come out to see the fire hydrant that was underwater; did the Fire Chief make any recommendations for a different location (Exhibit B).

Janet Davis here to address the rollout of 5G technology coming to our town; which is short distance technology; millimeter wave technology which means that it doesn't travel well. They are going to be installing cylinders onto the top of the telephone poles, do we need 5G? Is this worth the risk to the environment and the health of our residents, and also the infrastructure? What will happen to our property values? (exhibit C)

Kris Clark from the Land Acquisition and Preservation Committee (LAPC) shared her experiences as a volunteer on the Committee. Some of the things the committee has accomplished is reviewed the open space and recreation plan; reviewed conservation restrictions, making recommendations; walking weekends in the spring and fall of open spaces, maintained the trails among just a few of the things we have done. Farley Lewis a member of the LAPC, has served for several years, believes the LAPC should continue as a committee; or become an Open Space Committee.

Ann Canedy as LAPC Chair wants the committee to continue; spoke about the organization of the town; the citizens are at the top. We are volunteers on the committee, this group is talented and enthusiastic and active; please reconsider the repeal of this committee.

Allison Alessi as Chair of the Renewable Energy Commission, our mission is to promote energy conservation, efficiency and finding sources of renewable energy. We have an active committee, still has a roll to play in the town. Some of their accomplishments include: focused on the green communities act; worked with the cape light compact; supported charging stations for electric car and LED street lights. We would like to continue to promote renewable energy, this is an important issue.

Gordon Starr on the Renewable Energy Commission feels the commission has been doing great work, tonight isn't the end; tonight is your night to ask the questions how did we get here?

John Julius, spoke about the newly organized Greater Hyannis Taxpayers Association (GHTTA), stated the nonprofits are killing us. Sturgis just bought the Wings building, which means they won't be paying the taxes on that property as well. Gave an example of what Cambridge is doing to alleviate the tax issue on nonprofits. We need to work together.

Wendy Paquette a member of the Sandy Neck Board, indicated that at their last meeting on the 14th of May, one day prior to the due date the appointments committees form, three members filled out the form, but somehow it did not make to the Town Council office in time. She feels that of the Tom O'Neil, Rich French and she were wronged. Fortunately Tom was reappointed and two of us were not. Neither of our liaisons came to our last meeting to thank us for our years of service. Regarding the article in the newspaper, there is fresh blood; I do not consider myself stale blood or old blood. When did all the interviews happen, I am upset by the way I lost.

Bill Cimbrelo concerned we are dismantling our Renewable Energy Commission, lets do the right thing, be a beacon of light, stand for the right thing, for the future of our country and economy.

Bill Carey member of the Sandy Neck Board, we have an interesting mix of members, we have a diverse group, and we hold respect for each others views. Rich French is a dedicated, tireless board member, as our Chair for over a decade. No one is more dedicated. Wendy attended all of the monthly board meetings for more than 10 years before becoming a member of the committee. Could you please address my concerns and reappoint Rich and Wendy to the Sandy Neck Board. Do a proper vetting process.

Joyce Flynn Chair of the Yarmouth Energy Committee, who has always admired the work done by the Town of Barnstable; grants, parking, and amazing solar installations, aspire to be like your Renewable Energy Commission

Susan Truitt in her opinion the Town of Barnstable is facing so many issues, now we have Vineyard Wind, people should be a major component, why dilute a group that could help you in this endeavor

Meg Loughran were all the new appointees to Sandy Neck Board interviewed?

John Boyle in favor of retaining the Renewable Energy Commission has observed the meetings whose primary role is to act as a resource to the town. What is most important is to work as a team with the town. All active, well informed committee members, hope you will reconsider, the committee adds expertise to the town.

COUNCIL RESPONSE TO PUBLIC COMMENT:

All thanked everyone for coming out!

Taxpayers have taken care of all our social, public education, libraries, and physical needs; the nonprofits do bring in jobs and investments; energy conservation is paramount. At the last Homelessness Committee meeting some of the members of GHTA joined the meeting to discuss what is actually happening, we are growing; make Hyannis drive its own bus, be part of the future. We hope to have all the Councilors serve on the various Hyannis Boards. Thank you for volunteering on the committees! Proud of the passion, we try to be as attentive as possible, conversation is going to continue. To address Ms. Duran's comment, after the last meeting, the Fire Chief, Peter Burke, dispatched someone to the submerged fire hydrant, he contacted the water department and they did take care of the fire hydrant. We need to do a better job vetting the process, needs to be more input and discussion; we work for the best interests of the town.

The process for appointments and reappointments are not automatic, must be vetted by the Appointments Committee and voted on by the entire council. Deadline of May 15th was communicated with the various committees in April. To be considered for reappointment you must send in the paperwork by May 15th to the Town Council office. The reason for the deadline is to cover the whole process which requires a first and second reading by the Council. Some people did miss the deadline; however we gave them the opportunity to apply.

Rob Steen, Assistant Director of Public Works Department introduced the team that worked on this study.

Councilor questions and comments:

Cost effective excellent job on Lopes field, there is a need for a junior type baseball fields: more rectangle fields; parents want organized sports; concerned about the 15 year wait for the field in Barnstable Village, what about volunteers to help out in cleaning up the fields and fund raising for the fields; how does the filed study dovetail with the open space [Patty Machado, the field study was used with the Planning and Development Department - we looked at both together] any recreation needs not previously contemplated in the field study [will get back to you on that] survey on the Open Space are these results from that survey [no this was just the field survey] Would have been good to combine the two studies. Do you have a matrix for the entire town, [Yes] I would like to see that; Elizabeth Lowell field ranked at a medium level? [Yes, due to the turf conditions] So we have no fields that are considered number 5? [No] what fields can be used for multi-use [we do have soccer/rectangular fields] must be a tough grading process; Lorusso Field is the envy of many in the Little League District; many companies invested their time and energy to this field. Further discussion on how these rankings will interact with CPC discussions, how do we find value in the report [CPC was involved with this committee, they are using this to inform them of the need for a project] Funding was requested for some of these fields; we need to make sure you make a presentation to the CPC. Budgeted one tenth to one fifth necessary to maintain the fields [estimate is rough, not enough in the annual maintenance budgets of the DPW and School Department to keep and maintain an active field] not improving, just to mow, water, and feed the municipal field [Yes].

Town Manager, Mark Ells, findings of this report is not a surprise, majority of these fields are not under the maintenance of DPW. We need to notate which ones fall under the DPW and which ones fall under the Schools for maintenance; we need the volunteers; what you are hearing tonight, is the actual need for the fields. Once we make the capital improvements as we have with the high school, we need to maintain those fields. The CPC has had many conversations with us regarding the fields and plan to move forward.

Councilor questions and comments: The CPC had turned down the Osterville fields but gave the money to other fields; we do have community groups, companies, that want to help out; generosity of the people of the town, we need the community to step up and we need to embrace that as well.

2018-166 ADMINISTRATIVE CODE AMENDMENT- TERM LIMITS FOR CHAIRS OF MULTIPLE MEMBERS BOARDS, COMMITTEES AND COMMISSIONS INTRO: 06/07/18, 06/21/18

Upon a motion duly made and seconded it was **ORDERED**:

Section 1.

That §241-8E of the Administrative Code be amended by adding the following sentence after the first full sentence contained therein: "No Chair shall serve more than three (3) consecutive terms." So that §241-8E shall read:

E. Multiple-member board internal organization. Each multiple-member board shall, at a minimum, annually elect from its membership a chair, vice chair and clerk. Boards may

further elect a treasurer, and such other officer or officers as are deemed necessary or as is required by statute. No Chair shall serve more than three (3) consecutive terms. The annual election shall occur in July of each year, or as near after appointment of new members by the Town Council. The Town Council shall be notified of the officers of the board upon their election. The chair shall preside over all meetings of the board, and shall be the official representative of the board in all proceedings before the Town Council and other officials of the Town. The vice chair shall perform the chair's functions, in the absence of the chair. The clerk shall be responsible for the certification of the board's meeting minutes, observance of the public records law, and maintenance of other records of the board.

Section 2.

That this amendment shall take effect on July 1, 2019 **VOTE: Indefinitely postponed-unanimous**

ORDERED: That the sum of **\$340,000** be appropriated for the purpose of making temporary repairs to Butler Avenue, Ocean Avenue, Clark Avenue, Prospect Avenue, Hotel Avenue, Summerbell Avenue, Lake Elizabeth Drive, Valley Avenue, Laurel Avenue, Vine Avenue in the Village of Centerville, and that to meet this appropriation, the Town Treasurer, with the approval of the Town Manager, be authorized to borrow **\$340,000** and that the Town Manager is authorized to contract for and expend the appropriation made available for this purpose, and that the Town Manager is further authorized to assess betterments and to accept any grants and/or gifts in relation thereto. **VOTE: PASSES 13 YES**

Appointment Committees Overview

President Steinhilber explained the leadership gave a task to the Appointments Committee to look at all the boards, committees and commissions to take an inventory of the committees to see if there were any redundancies, streamlining; making them more impactful, cutting back on the hours of the volunteers while utilizing the talent but possibly aligning committees. This is the beginning of the recommendations:

Appointments Committee Chair Rapp Grassetti gave an overview of the process and the people involved in reviewing all boards, committees and commissions; , a list was formulated, for instance the Agricultural Committee has not met in years, has vacancies that were never filled. This was a way to analyze all the boards committees and commissions with a new view. Being on the Appointments Committee is really an honor; the citizens bring their varied backgrounds and expertise. Over the years this town and the staff have grown considerably, sometimes you just have to reset; tasking the committees is important and should follow the direction of our strategic plan. We want to see more task forces charged with specific things to come back with recommendations; we would like to align the Renewable Energy Commission charges more closely with the

DPW, because it falls under their purview.

The Land Acquisition and Preservation Committee, has done a great job, have worked on conservation restrictions, assisted Planning and Development to come up with a new document. Maybe a new committee to protect our open space, to promote our pathways; I would be in favor of exploring that.

Councilor Levesque, encouraged meeting and interviewing the volunteers to our boards/committees/commissions; encouraged by the passion of the residents, the knowledge they bring to our community; the idea was to become more efficient; my hope is to move forward and work together more effectively.

Councilor Neary, treat to interview and speak with the very knowledgeable volunteers; my belief is that it will bring renewable energy more to the table in a stronger position in the new committee. This is a very important committee in the town, going from 18 members to 7 members. I hope to get feedback; many of the people we spoke with they felt they were not being heard; not a good enough give and take.

President Steinhilber: Thank you to the Appointments Committee, this is the thought process that has gone on over the last months; the survey's that went out to all the committees, common theme was meeting for the sake of meeting. We want to make the volunteers time more impactful.

Councilor Dagwan, we looked at this because quite a few committees were not meeting at all or having issues with a quorum; concerned about the process, we have to give people time to accept the change. We do not need duplication, some committees were overstepping their bounds; we have to respect the people who put in the effort. Through this process, we have to take the views of the public into consideration.

Upon a motion duly made and seconded it was **ORDERED that:**

SECTION 1.

The Town Council hereby amends the Administrative Code by striking Section 241-30, Public Works Commission, in its entirety and by substituting in place thereof the following: <u>§ 241-30</u>. Infrastructure and Energy Committee,

<u>A.</u>

Term of office. There shall be an Infrastructure and Energy Committee consisting of seven regular members. Members of the Infrastructure and Energy Committee shall serve for terms of three years, so arranged that as equal a number of terms as possible shall expire each year.

В.

Authorities and responsibilities. The Infrastructure and Energy Committee is a standing committee serving as an advisory board to the Town Council, Town Manager andDepartment of Public Works. The Committee's charge is to:

(1) provide the Town Manager and the Director of Public Works with recommendations

concerning the development of rules and regulations for the maintenance and sanitary operation of the solid waste transfer station, water pollution control facilities, public roads, bridges, sidewalks, parking lots, parks, bulkheads, docks, Town landings, beaches, playgrounds, recreation and conservation areas, cemeteries, Town forests, and public buildings, excluding schools.

(2) recommend viable methods for achieving energy conservation and for utilizing renewable sources of energy within the Town.

(3) promote energy efficiency programs available through the Cape Light Compact in residential and commercial sectors.

Town Council: The Infrastructure and Energy Committee interacts with the Town Council to advise the Council on those policies and legislative matters concerning public works and energy conservation and renewable energy activities within the Town. (2)

Town Manager: The Infrastructure and Energy Committee provides the Manager with recommendations in order to accomplish and effectuate its mission.

<u>(3)</u>

Other boards: The Infrastructure and Energy Committee interacts, as necessary, with any town board requiring or requesting assistance in matters of public works and energy conservation and renewable energy activities in the Town."

[They made two recommendations, regarding the Danforth property for agricultural purpose and also the Paine Black House for a farmers market, people just lost interest in the committee] This committee was educational group; aquaculture, shellfish farming, beekeeping and livestock presentations. Will it terminate or be picked up and covered by another committee; what is the plan. The focus of this committee was the development of the Danforth Property. As we go forward we can always change the code to add additional committees/commissions. There was crossover with the shellfish; and aquaculture. Farming or agriculture within the town was very difficult to get any group to move any project forward. We need to update the boards/committees/commissions application to remove any non existing committees.

Councilor questions and comments: The duties that were charged to the Personnel Board are now redundant, has not met since July of 2016 due to a lack of quorum; the HR department has been able to handle all issues

ORDERED that:

SECTION 1.

The Town Council hereby amends the Administrative Code by repealing §241-27, Personnel Board.

SECTION 2.

The Town Council hereby amends Chapter 242, Personnel, as follows: By striking the phrase "Personnel Director" wherever it appears in §§242-5, 242-6 and 242-7 and substituting in place thereof the phrase "Human Resources Director".

By striking the phrase "Personnel Board and" where it appears in §242-5B(2), §242-7A and §242-7B.

By striking the phrase "and the Personnel Board" in §242-6A.

By striking §242-3 and §242-4 in their entirety and sequentially renumbering the remaining sections under Chapter 242.

SECTION 3.

The Town Council hereby amends Chapter 401, Article VIII, Personnel Regulations as follows:

By striking the word "Personnel" wherever it appears in Chapter 401, Article VIII, Personnel Regulations, of the Barnstable Code and by substituting in place thereof the phrase "Human Resources" except under 401-82B and §401-97B(2)-(4).

By striking the phrase "except for persons under the control of the School Committee" in §401-81H.

By striking the phrase "Personnel Board" and substituting in place thereof the phrase " Human Resources Director" in §401-82B.

By adding the phrase "to the Human Resources Department" at the end of the second sentence in §401-83.

By striking out the definition of "Personnel Board" in its entirety under §401-84.

By striking §401-85B in its entirety and substituting in place thereof the following:

"<u>B.</u> Administration of classification plan. Each classified position is allocated to a grade. The Human Resources Director is responsible for classifying all positions. The Human Resources Director will recommend changes to the Town Manager for approval. When a new position is established or when a position has changed substantially as to the kind and/or level of work, the Town Manager, a department manager, an employee, or a recognized labor union may initiate a request for a change in classification by submitting a written request to the Human Resources Department accompanied by a position description questionnaire. The Human Resources Director shall document any changes in the position, its duties and/or responsibilities, evaluate the position and shall make a recommendation concerning the reclassification or reclassification request shall be final."

By striking the phrase "Town Accountant" and substituting in place thereof "Finance Director" in §401-85C.

By striking the second sentence of §401-88A in its entirety.

By striking the first sentence under §401-89D(1)(a) and substituting in place thereof "The vacation accrual for the calendar year in which employees were hired will be as follows:"

By striking the number "five" under §401-89D(4) and substituting in place thereof the number "ten".

Exigency defined as short notice deployment (limited to 7 calendar days from notice); military events and related activities, childcare and school activities, financial and legal arrangements, counseling, rest and recuperation (limited to 5 days from FMLA leave per leave), post deployment activities (up to 90 days from end of deployment)., additional activities agreed to by the Town and employee)."

Councilor questions and comments:

Would like to address the process, I was appointed as a liaison to this committee, listened to the accomplishments achieved by this committee, listened to their ideas; these are engaged citizens coming to the table offering their expertise to the town. I found the lack of transparency disturbing, checking the website, there was no information on the website on the members of the Appointments Committee or no reference to the Renewable Energy Commission in the minutes; this put me in a very awkward position; having no understanding as to why; reducing redundancies does not make sense to me. Renewable energy is at the forefront; with Vineyard Wind we have the opportunity to take a leadership role, I doubt that the new committee will have renewable energy front and center. How is this going to roll out? Going from 18 to 8 members, troubled by how it all went down, will not vote for this item.

I see this as an end run, trying to avoid the conversation of the Green Communities Act in our town. We are on the forefront on many energy issues, but when it comes to something controversial, we want to take a side step. To move this committee, I will not be supporting this item.

I need to let you know that the Town Manager is currently looking at the Green Communities Act. The Manager is looking at the Green Communities Act a long with the Building Commissioner is currently underway and will be making a recommendation to the Council.
