2022-185 RESOLVE RATIFYING THE TOWN MANAGER'S APPOINTMENTS TO THE LOCAL COMPREHENSIVE PLANNING COMMITTEE INTRO: 05/05/2022

Mark Ells, Town Manager introduced Karen Nober, Town Attorney talked about the appointment process to appoint the members. Karen provided the authority to appoint the Local Comprehensive Planning Committee (LCPC) lies solely with the Town Manager, the Council has no role in the appointment process but has statuary role at the end of the process to approve the Local Comprehensive Plan (LCP) that is created by the LCPC. The Town Manager voluntarily seeks ratification from the Town Council of his appointments, and involved two

Councilors in the selection process. The items were bifurcated to allow one or more councilors to recuse themselves from the vote on one or more candidates.

Mark Ells, Town Manager continued with the rationale. The LCPC is to steer a process to unify Barnstable's Villages for future growth and development and resource protection.

Councilor's Cullum and Bogan joined Town Manager Ells to interview 21 applicants; tried to get at least one person from each village

Councilor questions and comments:

(Mendes) we tried various methods of outreach, but we missed many, if we value equity we have to create ways for all to have a voice. Something as simple as a letter to every voter would have made a difference. We failed. (Atsalis) The group for this committee is some of the same people that always come forward, just because they show up it could not be the only voice we listen to, it is a form of arrogance. (Cullum)As a participant in the process, everything was done with good intent; we don't have the relationship with parts of our community; it's disappointing, these relationships take a long time to build; don't see a way we can move forward without a diversity, equity and inclusion, we have a lack of diversity; we don't have the credibility with the full audience. We can use some improvement. (Bogan) I was a bit skeptical at first, I think we had very good discussions, if there was opposition we articulated our concern for the person, and ultimately agreed. We narrowed the field from 54 to 21, we could only trust that there was sufficient outreach, the list was what it was, and we did the best that we could to narrow it. We had failed to identify a person from one of the villages, what was disconcerting, there was an additional meeting that I was unable to attend due to a conflict, and was not happy with one of the names on the list. I had strong opposition to Meaghan Mort and felt my voice was not heard. (Rapp Grassetti) No matter how you do this someone isn't going to be happy, my village isn't happy, same people a rehash of all the committees, all the same voices, disappointed that some younger people did not make it on this list. This was an opportunity to hear new voices and ideas. (Cullum) Touching on Meaghan Mort is the sole renter, someone that struggles to keep a roof over her head; we needed someone who suffers, we need her voice on this committee. (Shaughnessy) Appreciate the process, one thing that Meaghan always does is speak from the heart, takes an incredible amount of courage to be that voice; Osterville and Centerville are heavily presented, but it is a good representation they bring other qualifications to this committee. I will support the slate of candidates put forth; we extended the application period good job done by everyone. (Schnepp) Our representation in our committees are not diverse, we need to focus on diversity. Some of the issues are the time necessary in participating in these committees. Hopeful that the LCPC will make sure that all the voices will be heard; we are under an obligation to start the LCP. I will support. (Mendes) Very disappointing that everyone is willing to settle; we can do better, people on this committee are going to determine the lives of all the people in our community. I will not support this as it is not representative of this town. Starting over again is hard sometimes you have to, this is not right. (Hebert) I like that there are more women than men on the committee, these people are willing to serve and give their time; this is going to be a plan to consider the future of this town. A consensus of what we will see in the future, to use this as a guide. (Ells) I was tasked to create an LCPC that can guide this plan forward, the committee serves as a steering committee, the villages and residents may participate in the development of this plan. All 7 villages will have a voice. The intent was to engage, the profile of this committee isn't different, we chose from those who applied. Tried to reach everyone, we chose from the group that applied; if we pause this, will a different result occur in the time frame we wanted to move forward. I wanted more youth to participate; I believe this committee can serve us. (Levesque) We have a leadership meeting on Monday mornings; we didn't have input we just listened to the input of Town Manager Ells.

Lindsey Counsell, Chair of Community Preservation gave the rationale with Ed Pesce who gave an overview using a Power Point slide presentation. Jonathan Stone (JD Stone) stated that multiple teams participated in the Opening Day Ceremony on April 30^{th.} We hope to keep growing the Little League.

Councilor questions and comments:

(Neary) Looks like a worthwhile project, what will you be doing with the trash (Pesce) Field has been used for years (JD) All volunteer board, we will take care of the trash in season twice a week. (Atsalis) Support this project and the funding, great program, maintain the best fields in the town, need the restrooms, and I fully support this item. (Schnepp) understand the value of this project, preservation funds have some restrictions, can you discuss some of the concerns (Counsell) We did a thorough review, using town lands and town funds, it will be under the purview of the Town Manager; it is a good mix. (Schnepp) any opportunity for other groups to use these facilities (Pesce) when we went through this we met with the Recreation Commission staff and talked to the schools, it was too much to manage at the time, decided that Barnstable Little League will be responsible, and it will go through the Recreation Department to control the usage of this field. (Attorney Connolly) Spoke with the Department of Revenue (DOR) after reading the statute, funds are still not allowed for concession stands bur are allowed for the bathroom facilities. (Lauren Friel) would like to make her comment, currently sitting at the Little League Field; we desperately need the bathroom facilities. (Joe O'Brien) The control of the Little League Complex is under the supervision of the Barnstable Recreation Department. This project is the icing on the cake; it is needed, going to go a long way to enhance the experience.

(Neary) Bids came in lower, logistic issues to get the work done; this plan has more units involved, maybe add additional units while the price is right, maybe accelerate the program. (Lambros) This money is allocated and can only be used for this project, hoping to do potentially 3 additional units (Rapp Grassetti) Last year's CIP was for units 1, 2, 3 and 10; This year the units 1, 2 13, and 16 why is that? What are all other costs? (Lambros) steel underneath these units, the roof will be lifted because of the potential snow, labor costs are the highest part; (Rapp Grassetti) what is the 2.5 million acquisitions or construction? (Lambros) where are you seeing that figure, roughly 5 to 700 thousand for each unit (Gareth Markwell, Deputy Finance Director) 600,000 is the cost around the lifting of the roof, auxiliary cost to put in a new unit Numbering of the units this year it is for the Barnstable Intermediate School (BIS) last year it was for the Barnstable High Schools that is why the numbering is confusing.

(Lambros) Once you get passed the early 90's it is difficult to find any documentation, or records of projects.
