    - Mooring update – The deadline for mooring renewals is March 31<sup>st</sup>. Because it falls on a weekend – renewals will be accepted on the next business day with no late charge. There are 600 mooring permits that have not been renewed to date. The late fee is \$50. The deadline for late renewals is May 14<sup>th</sup>. 184 people did not renew their place on the waitlists. Seasonal jobs have been posted on the Town website.

Marina update – There were 25 people who did not renew their place on the waitlists. Slip contracts will be mailed on Monday, April 2<sup>nd</sup>. Barnstable Harbor Marina floats/docks are in. The new docks for The Marina at Prince Cove will be in this week.
