#### **Notice of Intent (NOI):**

- 1. Aristedes N. Haseotes, Trustee 196 Long Beach Road, Centerville. The project as proposed is to modify the existing float. An 8' x 40' float is proposed for berthing a 46' power boat. No objections from the committee as presented. (Copies available at 1189 Phinney's Lane).
- 2. William and Christina Staudt 95 Eel River Road, Osterville. Proposed construction for a boardwalk, pier, ramp and float for non-motorized craft.
