Background

The North Street Parking Lot – West is located at 249 North Street. There are two (2) vehicular entry/exit points to the parking lot located on North Street and a pedestrian entry point from Main Street. The parking lot has 129 parking spaces including five (5) accessible parking spaces. There is one accessible space located near the entrance to the parking lot (near the building company), two (2) accessible spaces near the Hospice Education Network and two (2) accessible spaces near the comfort station. In addition, there is one (1) electrical vehicle charging station near the H.C. Wainwright Building.

Key Accessibility Issues

Accessibility issues in and around the parking lot include walkways that have running and cross slopes and changes in level that are greater than the maximum slope allowed.

Accessible Parking Space near North Street:

Lack of maintenance at the parking space. As a result, the access aisle does not prevent accumulation of water and the identification sign is tilted.

Accessible Parking Spaces near the Hospice Education Network

- Identification signs are lower than the minimum allowed.
- One of the signs lacks the International Symbol or Accessibility (ISA) on the identification sign.

Accessible Parking Spaces near the Comfort Station:


- The access aisle at the accessible parking space is narrower than the minimum required.
- The identification sign at the van accessible space lacks the designation "Van Accessible".
