Campfires on the public beach have become very popular. Staffing is required to manage these gatherings in order to ensure public safety and compliance with our rules and regulations. Tasks include issuing permits, enforcing time limits and location of fires, handling group dynamics and safety concerns, ensuring proper fire extinguishing and beach clean-up.

Proposed 2WD Camper Test: 2021 \$ 25.00

Two-wheel drive campers require a one-time test in order to be eligible for a permit. This fee will only apply to new permit applicants and/or applicants that have a new two-wheel drive camper. The fee is designed to capture some of the staffing costs associated with administering the test. In addition, it is hoped to have an online camping reservation system in place by 2021 and will likely require a reservation fee.

The Sandy Neck Board voted to endorse these proposed fee increase at their October 19, 2020 Meeting.

1. We will be converting ORV permit renewals to an online platform (MooringINFO). This will improve the ORV permit purchase process for patrons and will likely increase revenue (compared to 2020 when everything was done via the mail and folks could not be bothered with the cumbersome process).
2. We have recommended an increase in the price of the ORV permits (estimated increase in rev. ~\$21K).
3. We have recommended a fall ORV permit price (estimated increase in rev ~\$12K).
4. We have recommended an increase in the campfire permit fee (estimated increase \$9K).
5. We have recommended an 2-WD camper test fee (estimated rev. \$600)
