	At the last Council meeting, town staff explained its recommended approach to populating
	a Local Comprehensive Plan (LCP) Committee. That draft is out for public comment now.
	Citizens are looking at this process closely, particularly as staff stated in response to resident
	questions before the process started, and before Council or community conversation, that it
	was eliminating the Village Planning process as has been done in the past and taking what it
	called a 'different direction'.
	In reviewing the staff's preferred committee composition this weekend, a group of us
	observed that the list of the specifically prioritized boards and commissions did not include
	any with a historical role, expertise, or point of view as set out in our Town Code.
	We then noticed that the Town Code (Section 241-47.36 B) states that the Planning
	Department's "[c]omprehensive Planning interacts with the Planning Board, Zoning Board of
	Appeals, Historical Commission, Old King's Highway Historic District Committee, Hyannis
	Main Street Waterfront Historic District Committee and Appeals Committee, Conservation
	Commission and Board of Health and other boards and commissions as requested." (Bold
	added) It stood out that none of those Committees or Commissions with expertise in the historic
	·
	nature of our built community so valued by our Town Code that are to interact with
	comprehensive planning were listed in staff's draft. Yet, other commissions with no
	specified role in comprehensive planning are.
	Your work to protect and preserve the history and aesthetic of our community is

Oct 25 email	Director Jenkins, Thank you for your email and a copy of the LCP Committee Memorandum. I am seeing this today for the first time. Following a quick read, I expect to have some comments/thoughts that I'd like to share. However, I feel that your request for responses on this Memorandum from the public by November 1st is unreasonable. As you and Town Manager Ells have both stated numerous times, the LCP process will be extremely important to the future of the Town of Barnstable. Given Phase I alone is expected to take at least 18 months, I feel strongly that the period for the public to be made aware of, read, digest and comment on the proposed guidelines for appointing Committee members should be at least 30 days. The Town Council requires two readings (i.e., essentially 30 days) for the appointment of members to any of its volunteer committees/boards. Considering the importance of the LCP process and your stated desire to obtain robust input from the public, I ask that you extend the date for public comment on the Memorandum until at least until the November 18th Town Council meeting. This date will provide a more reasonable time for the public to review and respond to the Memorandum and will assist the Town in avoiding the appearance that it is attempting to rush the process of appointing LCP Committee members without adequate input from the public. The Osterville Village Association board met Tuesday, November 2<sup>nd</sup>, and discussed the Local Comprehensive Plan (LCP) Committee Establishment & Appointments document you distributed for comment on October 21, 2021. There were several issues with specific aspects of your proposal brought forward by our board. We contact you to express our deep concern with one of those proposals.

Under the considerations for selection of appointees by the Town Manager, it states that the committee "shall include residents from each and all of Barnstable's seven villages." Including residents who live in each village does not mean that a member will represent and advocate for the interests of that village. Additionally, it does not ensure communication with village residents as the process moves forward in order to bring back village input. For example, under your proposal, you could select a member to provide the perspective of one of your preferred Town Boards or Committees, who lives in a certain village, and use that member to check the village box.

We urge you in the strongest terms to respect village and civic associations' perspectives in the 2021 process in the same way this Town has respected them in prior LCP processes. We ask for the same type and level of input opportunity in 2021.

It is the unanimous request of the OVA Board of Directors that the selection of village representatives to the LCP committee come by recommendation of the various Barnstable civic associations and then move through the appointment process you identify, i.e., interview with the Appointments Committee, etc.

The successful adoption of the upcoming Local Comprehensive Plan will depend upon a fair and transparent process from the start. A representative from each of the seven Village civic associations having a seat on the LCP Committee, consistent with the level and type of input they have had historically, will help ensure that success.

During the Monday, November 8th, meeting of the Centerville Civic Association (CCA), members of the Board and other association members discussed the process outlined in your Memorandum to the Town Council, dated October 21, 2021, regarding the Town of Barnstable Local Comprehensive Plan (LCP) Committee Establishment & Appointments. Following our discussion, a majority of those in attendance voted to write a letter to you from the CCA Board to share its thoughts on the process proposed in your Memorandum.

The CCA Board and association members are very aware of the need to update the Town of Barnstable's LCP and are pleased to see this process get under way. While we are optimistic and assume that it is the Town's intention to include a representative of each of the Town's seven village civic associations on the LCP Committee, we want to express our opinion that it is essential that the village civic associations have a seat at the table and direct input into the LCP process.

Dear Mr. Ells and Ms. Jenkins,

We are writing to you with comments on Mr. Ells' Memorandum to the Town Council, dated October 21, 2021, regarding the Barnstable Local Comprehensive Plan (LCP) Committee Establishment & Appointments (the "Memo"). We ask that the requests outlined below, as well as any others that the Town may receive in response to its request for public comment on the Memo, be discussed by the Town Council during the LCP update you plan to provide during the November 18<sup>th</sup> Town Council meeting (or such date your update is provided).

**First**, we are very concerned that the process outlined in the Memo departs from that which has been used in the development of prior local comprehensive plans in Barnstable (e.g., 2010 and 1997 plans). Prior LCP's started with the development of Village plans for each of the Town's seven villages. Those plans were largely developed by and with the assistance of each Village's civic/village association and were key *inputs* to the LCP process. For the 2021/2022 LCP, Town staff has publicly stated that it wants to "zoom out" from Village plans and will instead replace that with a "robust civic engagement program."

## Request: In addition to robust civic engagement, we ask that the update and development of Village plans be undertaken at the start and included as an *input* to the LCP process.

**Second**, we feel it is extremely important that each of Barnstable's seven civic/village associations be asked to select a representative member to sit on the LCP Committee. Village representation is arguably just as important as some of the Boards/Committees/Commissions identified in the Memo (e.g., Airport Commission, Youth Commission). Additionally, as housing is such a priority for our Town, we believe the exclusion of a representative from the Housing Committee from the LCP Committee would be a significant omission.

If the argument is that staff only wants 9 - 15 members on the LCP Committee because a larger number will make the process too difficult or cumbersome, we'd like to point out that earlier this year, the Town Council amended the Town Code to increase the Youth Commission to **19** members. The Town's rationale for increasing the size of the Youth Commission was to increase the participation of interested parties.

Request: As the LCP Committee will be responsible for overseeing development of the Town's comprehensive plan for the next ten-year period, we believe there will be many interested parties and the role of this Committee is equally if not even more important than that of the Youth Commission. Therefore,

we ask that a representative from each of the Town's seven civic/village associations (as selected by the associations) be included on the LCP Committee, even if that requires the size of the Committee be increased beyond 15 members.

Third, it is a well-known fact that many of the members of the Town's Boards/Committees/Commissions have either personal or family-related financial or business interests that could have an impact on the positions they take with regards to certain matters discussed and/or decisions made by the LCP Committee. This is true for all potential members of the LCP Committee – not just those who are on a Town Board/Committee/Commission.

Request: We ask for the close consideration and full disclosure of any personal or family-related financial or business interests of potential members during the selection of members for the LCP Committee.

Thank you for your serious consideration of the above requests and we wish you luck in the LCP Committee Selection process.

Thank you for the opportunity to make public comment on the Local Comprehensive Plan. In reading your letter to the Town Council regarding the selection of the LCP Committee, I was surprised, and frankly dismayed, to see that after assuring that each village will have a representative on the committee (#1), you state that priority will be given (#2) to
representatives from 7 Town committees/departments.
That's already 14 representatives on a committee that you say will have 9-15 members. You state that there should also be a representative from the business community (#3). That makes 15 representatives for your committee.
So I need to ask you, what about the representatives that are needed on the committee from items #4 and #5 in your letter? For #4 you say there should be representatives from "priority issue areas, including land use, transportation, water quality, public infrastructure, housing, environmental protection, historic preservation, climate change, and public health."
I agree with you. All of these subjects should be prioritized for representation on the committee. They represent most of the stakeholders in this town. It is essential that these areas are represented. But that's another 10 priority positions.
You state that the committee should include representation from various demographic groups (#5). Again, I agree with you: youths, families with children, retirees, property owners, etc. That makes several more stakeholder groups deserving of seats on the Committee.
Who actually gets prioritized?
I'd like to make a suggestion. Since you state in your letter that you will provide assistance to the Committee from Planning and staff from all other Town departments "as necessary," it seems redundant to have these departments taking up seats on the Committee when those departments can be available in an advisory capacity to the Committee. Those 7 seats you've prioritized to Town departments can be more appropriately assigned to the many other stakeholders you've prioritized in items #4 and #5.
Selecting members from the various constituencies you've named in items #4 and #5 will advance your stated goal of gaining important input from the community. Giving away 7 seats to people who already represent Town government seems to defeat the purpose of broad citizen participation. The LCP is supposed to represent the collective will of the people who live in Barnstable, not the ambitions of Town departments.
Finally, the stated reason for the LCP is to develop a new community-based 10 year plan for" growth and development and resource protection". I urge you to bear in mind that "resource protection", not "growth and development" must be the Number One Priority for the LCP. If resource protection is not our first priority, growth and development can not possibly flourish.

Dear Barnstable Town Council Members:

Please begin the **2021** Local Comprehensive Plan by creating a process that respects and maintains the first goal of our current Plan: "Sustain diverse villages and livable neighborhoods for year-round residents while providing housing opportunities for all."

Please also give effect to the top guiding principles of your 2021-2022 Strategic Plan: "involving residents in the decision-making process" and "modeling ethical behavior".

To those ends, we ask the Town Council to:

- **1.** Be consistent with prior plans: include Village Plans as *input* to the *2021 Local Comprehensive Plan*.
- 2. Have a dialogue in a public venue as to whether and why each Councilor believes or not - that the town's *Comprehensive Wastewater Management Plan* supplants our Village Plans as relevant contributing factors to the initial planning process for our *Local Comprehensive Plan*, i.e., staff's statement of belief that a sewer plan "necessitates" "zooming out from villages". (source: Channel 18)
- 3. For any Plan working committee, a) ensure a majority of members are residents without personal or familial financial or business interests in the outcome and b) provide a seat for a representative nominated by each Village or Civic Association (not members selected from a prioritized Board or Commission who happen to live in a certain village.)
- 4. Provide visibility into any Plan committee member's personal or familial financial interest in the plan's outcome to give the public confidence in its integrity, consistent with our Town Ethics Code.
